### IMPORTANT PLEASE READ

**To: All Uniformed Members of the OHP**  
**From: Herschel M. Sigall**

**Subject: Toyobo Settlement Distribution**

As you know we have been working to see that the Toyobo settlement monies reach as many of our officers as possible. Although we have made progress in getting qualified OHP officers to register for the settlement and submit an Election of Benefits Form required for participation, we still have a long way to go. I admit to some frustration in trying to encourage people who have money coming to claim that money. Here is the current status of our efforts:


1. To date 151 current and retired members of the OHP have received payment of \$730.00 representing the first pay out from the 29 Million-Dollar settlement in the class action suit filed against Second Chance and Toyobo. I am pleased that we have been able to see distributed \$110,000.00 thus far to OHP officers. I am especially pleased since we defeated an attempt to require these funds to be paid to the OHP instead of our officers.
2. There are currently an additional 261 OHP officers "registered" for a second distribution of the settlement funds. These funds total approximately 2.5 Million Dollars and were set aside to pay to officers who registered later than the initial required date for registration and submission of an Election of Benefits Form. Seventy six officers of this total of 261 have filed an Election of Benefits Form. You will recall that we sent out EOB's with instructions on where to mail the form. That leaves 185 OHP officers who we have registered but who will have not filed the necessary EOB Form.
3. Many of you who are registered to participate in the second distribution may not even know you have been registered. You were registered through a combination of our filing for you and the OHP filing your names when it attempted to have the settlement distribution paid to it. A number of Lieutenants and higher rank officers are part of the 185 officers currently registered but who must file an Election of Benefits Form to be part of the second distribution.

4. If you see your name on the enclosed list with an "x" to the left of your name, you have already filed an Election of Benefits Form and are ready for the second distribution of settlement money. These names are alphabetically listed at the beginning of the enclosed list. If you see your name on the enclosed list but there is no "x" next to your name, you are registered but do not have an EOB filed.
5. Sometime shortly after July 1, 2006 everyone who is registered but has not filed an Election of Benefits will receive a letter from the Settlement Administrator estimating what their share of the settlement distribution will be and enclosing an Election of Benefits Form to be filled out and mailed or faxed to the Settlement Administrator. We will help you fill out the forms should there be any questions. In any event, you will be required to file the EOB in order to receive the payout.
6. Registration for the second distribution closes completely as of the close of business, June 30, 2006. That means there is still time for any officer, current or retired, who owned a Second Chance Ultima/Ultimax or TriFlex vest to register and participate in the settlement distribution. So if you have not already received your settlement check and if your name does not appear on the attached lists, but you owned a Second Chance Ultima/Ultimax or TriFlex vest, you can still register. Call our OSTA office and we will instruct you on just how to register.

As I see it there is still upwards of \$200,000.00 that could and should be paid out to current and retired OHP officers. Added to the \$110,000.00 already paid out to our officers, OHP officers will be well treated by the Settlement. But, you will have to help make it happen. Please look through the attached list.

Note, I did not include the list of officers who have already received a check for \$730 in the first distribution. You know who you are.
